**to the GENERAL TERMS AND CONDITIONS
of the SEMI-TRAILERS LEASE AGREEMENT**

SCHEDULE OF FEES AND COMPENSATIONS

1. Lost Property Documents (Clause 4.8 of the General Terms and Conditions):

Compensation of reasonable expenses and an administration fee shall apply. Reasonable minimum expenses are intended to compensate the Lessor for the costs incurred in obtaining new documents or duplicates thereof. The administration fee is intended to compensate the costs associated with the administrative actions related to the handling of reasonable expenses, including ordering documents, accounting record-keeping, and managing banking operations.

Reasonable minimum expenses:

Vehicle Registration Certificate	EUR 30 plus VAT
EURO Certificate	EUR 50 plus VAT
"XI – Testing Certificate"	EUR 75 plus VAT
"Certificate of Conformity"	EUR 40 plus VAT
"FRC" Certificate (applicable to semi-trailers with refrigeration equipment)	EUR 50 plus VAT
Where all of the above documents are lost	EUR 250 plus VAT

2. Property Returned Dirty, Unwashed, and/or with the Interior and/or Exterior of the Property Not Cleaned (Clause 3.2.29 of the General Terms and Conditions):

Compensation of reasonable expenses and an administration fee shall apply. Reasonable minimum expenses are intended to compensate the Lessor for the costs incurred in washing and/or cleaning the Property. The administration fee is intended to compensate the costs associated with administrative actions related to the handling of reasonable expenses, including arranging the Property for cleaning services, accounting record-keeping, and managing banking operations.

Administration fee	EUR 30 plus VAT
Interior and exterior washing of the Property	EUR 45 plus VAT
Disinfection of the Property	EUR 33.06 plus VAT
Removal and disposal of foreign objects, stickers, and adhesive residues	EUR 45 plus VAT

3. Failure by the Lessee to perform the obligations assumed under Clause 3.2.11 of the General Terms and Conditions: An administration fee of EUR 500 plus VAT shall apply for each instance of non-performance or improper performance of an obligation (an event / traffic accident to be administered by the Property insurer). The administration fee is intended to compensate the Lessor for costs related to the administration of the event, preparation of documents, accounting record-keeping, and management of banking operations.

4. Latent defects of the Property identified in accordance with Clause 4.6 of the General Terms and Conditions: An administration fee in the amount of ten per cent (10%) of the costs of

eliminating the Property defects, plus VAT, shall apply. The administration fee is intended to compensate the Lessor for costs related to coordination of actions, ordering repair services, preparation of documents, accounting record-keeping, and management of banking operations.

5. Occurrence of the events referred to in Clause 6.2 of the General Terms and Conditions: an administration fee of EUR 1,500 plus VAT shall apply. The administration fee is intended to compensate the Lessor for costs related to coordination of actions, ordering repair services, preparation of documents, accounting record-keeping, and management of banking operations.

6. Violations of Road Traffic Rules and/or other legal acts during the Lessee's use of the Property (Clause 6.11 of the General Terms and Conditions): compensation of reasonable expenses and an administration fee shall apply. Reasonable minimum expenses are intended to compensate the Lessor for the costs incurred in paying fines for the benefit of the Lessee. The administration fee is intended to compensate costs related to administrative actions associated with the handling of reasonable expenses, including forwarding documents received from the competent authorities to the Lessee, accounting record-keeping, and management of banking operations.

Administration fee applied in each case where the Lessor administers a fine, levy or other sanction imposed while the Lessee is using the Property (irrespective of whether the fine is paid by the Lessor or by the Lessee directly to the authority that imposed it)	EUR 15 plus VAT
